Major Responsibilities:

2. Support and train consumers in life skills related to community living in tasks such as job skills, transportation, handling finances, personal hygiene, behavior and personal issues that impact their ability to access the community.
3. Provide additional support services to consumers residing in the community, including:
 - help to resolve problems and counsels, as needed;
 - encourage consumers to develop good skills for daily working and living;
 - assist consumers in develop and access social networks in the community.
4. Develop and maintain needed information for all reporting requirements.
5. Represent EDUCATION CONNECTION to other agencies regarding consumer needs and program services, as needed. Network with other agencies to meet consumer needs.
6. Other duties as may be assigned.
